- 1. Borrower has a current EVPL library card in good standing.
- 2. Borrower has read, understands, and signs both this Lending Agreement and the Waiver below in the presence of a library staff member as a condition to borrowing from the Library of Things.
- 3. All items must be returned in the same condition in which they were issued, excepting normal wear and tear. Heavy items must be loaded, transported, and returned by the Borrower. All items must be returned clean.
